**WAIVER, RELEASE AND INDEMNITY**

\_\_\_\_\_, who is herein referred to as the "Releasor", hereby releases, waives and forever discharges the Caleb Company, a Tennessee nonprofit corporation, its trustees, directors, officers, agents, employees, if any, successors, insurers and volunteers, who are herein collectively referred to as the "Caleb Company" from any and all liability, claims, causes of action, loss and damage that may result from any injury to the Releasor's person or property, even injury resulting in death of the Releasor, arising out of the Releasor being a Student at or of Caleb Company, including without limitation of the generality of the foregoing those arising out of or in any way related to the Releasor participating in any Caleb Company conducted or sponsored program or activity whether at Caleb Company, off property within or outside of the State of Tennessee such as an outreach program which are usually conducted overseas.

Releasor hereby acknowledges that if Releasor participates in an outreach program conducted or sponsored by the Caleb Company or travels internationally on Caleb Company business that he or she is fully aware of the fact that his or her personal health, freedom, safety and/or life may be at risk of loss or damage from contraction of disease, accidents, terrorism, persecution, war, political unrest and any other number of circumstances that might while traveling internationally or while participating in an outreach program and that the Releasor will give such risks the Releasor's full consideration, prayer and thought in deciding whether or not to participate in any such activity and has given such risks the Releasor's full consideration, prayer and thought in deciding whether or not to sign this instrument and that Releasor has signed this instrument with full knowledge of those risks, voluntarily, and not under any duress or undue influence of whatsoever kind or nature.

Releasor hereby knowingly and voluntarily assumes full responsibility for risk of loss of health, bodily injury, death or damage to Releasor's property arising out of the aforescribed risks, programs and activities. Releasor hereby agrees to indemnify and hold Caleb Company harmless from any and all claims, liability, loss, damage, cost and/or expense, including attorneys fees and costs incurred by Caleb Company in defending against any such claims and in enforcing this agreement, that may be asserted against Caleb Company or that Caleb Company may suffer or incur as the result of Releasor being a Student at Caleb Company.

Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee and any other jurisdiction in which any cause of action or claim may arise or be asserted and is being given as an inducement to the Caleb Company to allow Releasor to be a Student at Caleb Company, and that if any portion of this agreement is invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect. This release, waiver and indemnity agreement shall be binding on Releasor and Releasor's heirs, personal representatives, successors and assigns and shall inure to the benefit of Caleb Company and its , directors, officers, agents, employees (if any), insurers and volunteers.
